Introduction

REGATRACE (Renewable GAs TRAdE Centre in Europe) is an EU-funded project under the Horizon 2020 Research and Innovation Programme. Started in June 2019, the project aimed to create an efficient trade system based on issuing and trading renewable gases Guarantees of Origin (GoO), including biomethane. The founding pillars of the project were:

- European biomethane/renewable gases certificate/GO system
- Establishment of national certificate/GO issuing bodies
- Integration of GOs from different renewable gas technologies with electric and hydrogen GO systems
- Integrated assessment and sustainable feedstock mobilisation strategies and technological synergies
- Support for biomethane market uptake
- Transferability of results beyond the project's countries

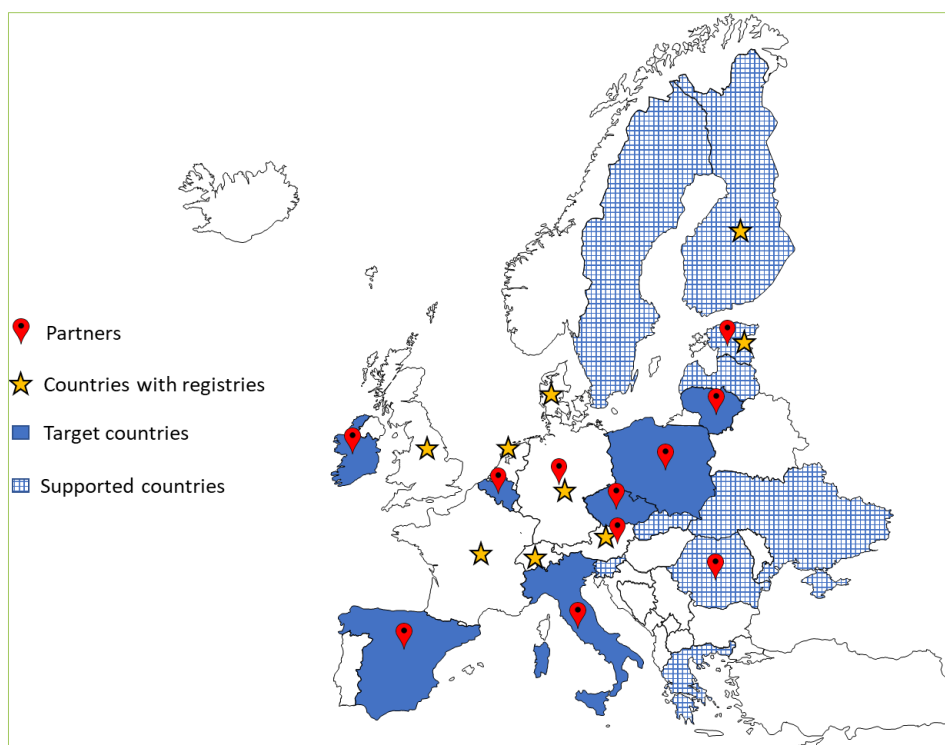


Figure 1: REGATRACE countries and partners

Structure

This Final Report on Dissemination, Communication, and Exploitation includes a list of actions from the original Dissemination, Communication and Exploitation Plan (D8.1) submitted in October 2019 and explains how these actions were completed. This includes a list of dissemination channels used as well as a description of all written, spoken, and online interactions. In addition, the efficacy of these initiatives is analysed.

1. Communication tools and activities

The communication tools and activities carried out during the REGATRACE project aimed to:

- inform the target groups about the activities and the outputs of the project;
- disseminate the project's results at dedicated events all around Europe as well as in news articles;
- valorize the results of the project during and after its lifetime (through a dedicated website);
- ensure open access to the results produced by the project.

1.1. Visual identity

Professional graphics designers shaped and developed the REGATRACE visual identity in order to allow the partners to communicate more effectively with the target audience and the general public. A visual identity manual, including guidelines regarding logo elements, project colors, templates, and fonts to use was developed in the original Dissemination, Communication and Exploitation Plan (D8.1) submitted in October 2019. The eight templates designed, along with the logo, were used consistently and correctly throughout the project.

1.2. Project website

The REGATRACE website (www.regatrace.eu) was designed and developed by ISINNOVA and officially launched in October 2019. The website, updated on a regular basis with news, deliverables, results and events, features a general description of the project, a section with links and contact information for the partners, a section with all public deliverables, a section for news and events, and a section with links to other projects addressing similar challenges.

The project website uses responsive design, which allows for a seamless browsing experience from various devices. This responsiveness is increasingly important for online communication. The website will be maintained for four years after the end of the project (until 4 July 2026).

Website's reach and engagement were monitored using Google Analytics. Enclosed an analysis of the website traffic from 1 January 2019 to 22 November 2022.

1.2.1. Audience overview 2019-2022

Since the launch of the website, there have been more than **20,000 users**. Each of them visited almost three pages, spending on average three minutes on the website. Most of the visitors came from the United States, the United Kingdom, Italy, Spain, and Portugal.

The peak of visitors in 2021 coincided with the organisation of the online workshop for issuing bodies and registry operators of energy attribute tracking systems in March, which gave high visibility to the REGATRACE project. In 2022, the peaks of visitors corresponded to the mention of REGATRACE in the Biomethane Action Plan in May, and the promotion of the REGATRACE Final Conference between October and November.

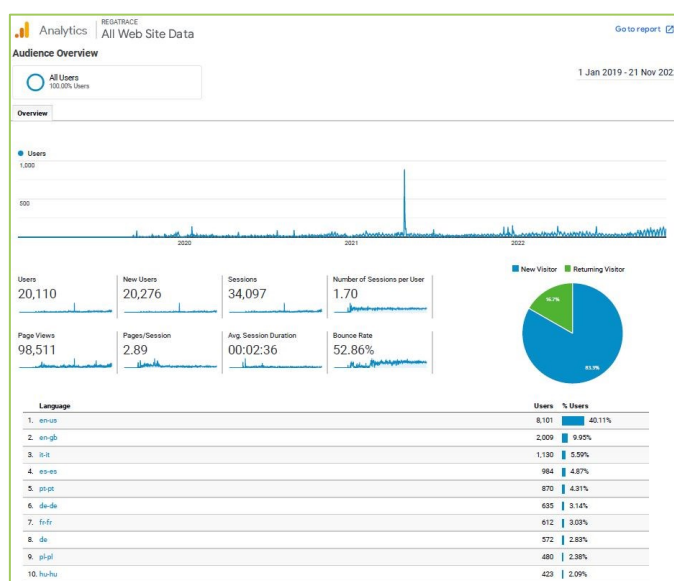


Figure 2: Audience overview REGATRACE website (2019-2022)

1.2.2. Page overview 2019-2022

Since the launch of the website, there have been more than **98,000 page views**. Most people who visited the website went to the homepage, the section about the project partners, and the downloads and deliverables section. Other popular pages were “Online Learning Resources” and “News”.

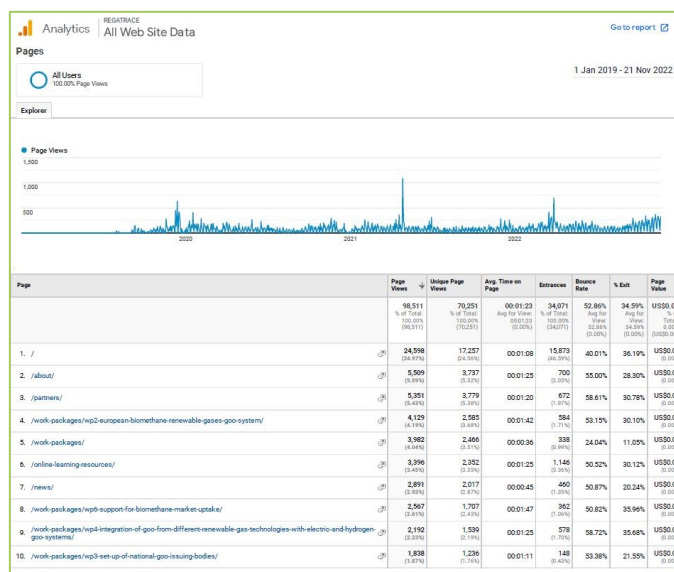


Figure 3: Page overview REGATRACE website (2019-2022)

1.3. Project leaflet

In October 2019, a project leaflet (4 pages) was produced by EBA in English and translated in the other languages of the project countries (Dutch, Estonian, French, German, Italian, Lithuanian, Polish, Romanian, Spanish), with 500 copies per language. It provides a short overview of REGATRACE, as well as information on the project's aims, activities and expected results. A Ready-to-Print version was shared with all the project partners. A digital version is available for download on the project website in the Deliverable area under "WP8 – Dissemination, communication & exploitation".

The project leaflet was circulated in conferences and workshops with the aim of generating interest among the target audience and to establish contact with them, starting from the very beginning of the project.

1.4. Project Roll-up

One project roll-up was created by EBA in October 2019 to grab the attention of visitors and participants at conferences, exhibitions, workshops, and other events. The roll-up was produced in English, Dutch, Estonian, French, German, Italian, Lithuanian, Polish, Romanian, and Spanish. The roll-up is available for download on the project website in the Deliverable area under "WP8 – Dissemination, communication & exploitation".

1.5. Newsletters

Seven online newsletters were prepared (at six-month intervals) by EBA over the course of the project. The project newsletters were one of the main communication tools that kept the target audience informed about the project's progress. At the time this report was written, there were **95 REGATRACE newsletter subscribers**.

The international versions in English featured news from the biomethane industry, updates on project deliverables and activities, and relevant news covering the sector developments in the countries of REGATRACE partners. The international newsletters were translated into the languages of the project

countries (Dutch, Estonian, French, German, Italian, Lithuanian, Polish, Czech, and Spanish). The local newsletters were translated and disseminated by the project partners. All newsletters are available for download on the project website in the Deliverable area under “WP8 – Dissemination, communication & exploitation”.

The most popular REGATRACE international newsletters were the **fifth** and the **seventh**. Enclosed are the results of these newsletters, according to MailChimp.

1.5.1. REGATRACE International newsletter 5

The fifth international newsletter was released on 22 November 2021. There was an opening rate of 65.5% and a total number of 18 clicks. The most-read articles were: [Harmonised set of rules for handling guarantees of origin in relation with energy carrier conversion: REGATRACE report published](#), [Act on the Promotion of the Use of Renewable Energy Sources in Slovenia](#), and [Biogas turns into biomethane](#). The newsletter was opened most frequently in France and Belgium.

1.5.2. REGATRACE International newsletter 7

The seventh international newsletter was released on 18 November 2022. There was an opening rate of 63.3% and a total number of 27 clicks. The most-read articles were linked to the promotion of the latest reports produced by the project: [New report on the set-up of biomethane registries](#) and [Recommendations to European and national policy makers](#). The newsletter was opened most frequently in Spain, France, and Lithuania.

1.6. Social media channels

REGATRACE also reached some of its target audiences through social media channels. A dedicated account was created on Twitter and LinkedIn to promote the project, using its news, events, and other information. As the project progresses, results and achievements were disseminated using these tools.

1.6.1. Twitter

The REGATRACE Twitter profile ([@Regatrace](#)) was created by EBA in July 2019 and has been fed with the project’s news, highlighting activities, participation in events, meetings, and conferences. Partners contributed to keep this account alive by providing inputs regularly. They were also encouraged to like and retweet posts from the REGATRACE Twitter account. At the time this report was written, the REGATRACE Twitter profile had **123 followers**.

Twitter activity of REGATRACE was monitored through Twitter Analytics. November 2022 was the month with the highest visibility since the launch of the REGATRACE Twitter profile in July 2019. Tweets posted in November 2022 had 2,411 impressions, and the profile earned near 2,000 visits.

1.6.2. LinkedIn

A REGATRACE LinkedIn page ([REGATRACE](#)) was created by EBA in July 2019 to reach a wide range of professionals from the renewable gas industry. Partners contributed to keep this account alive by providing inputs regularly. They were also encouraged to share posts from the REGATRACE LinkedIn page with their personal and professional LinkedIn account. At the time this report was written, the REGATRACE LinkedIn page was **followed by 481 professionals**. The audience was mainly composed of researchers, business developers, operators, traders, consultants, project managers, and media experts active in the renewable gas sector.

LinkedIn activity of REGATRACE was monitored through LinkedIn Analytics. As seen on Twitter, November 2022 was the month with the highest visibility since the launch of the REGATRACE LinkedIn page in July 2019. LinkedIn posts in November 2022 had 3,200 impressions, and the profile earned near 250 visits.

1.7. Media relations

Media relations were established with **three press releases** prepared by EBA and shared with more than 200 journalists. The press releases are as follows:

- 1) *[“A stable and reliable European market for biomethane”](#)*, released in April 2020, announced the launch of the REGATRACE project, detailing its objectives and main expected results.
- 2) *[“Biomethane industry sets 1st of its kind European Network to facilitate tracking of renewable gas certificates”](#)*, released on 20 December 2021, announced the set-up of the REGATRACE Network to facilitate collaboration on tracking and exchange of renewable gas certificates, and boost biomethane trading across Europe.
- 3) *[“Cross-border trading of renewable gases will support the decarbonisation of the gas sector in the path towards a climate-neutral Europe”](#)*, released on 21 November 2022, highlighted the main takeaways from the REGATRACE Final Conference.

The launch of the REGATRACE Network on December 2021 was covered, among others, by [Euractiv](#), [Bioenergy Insight](#), and [Biofuels Digest](#). The REGATRACE Final Conference organized on 16 November 2022 was covered by [Euractiv](#), [Bioenergy Insight](#), [Biogas World](#), [Bioenergy International](#), and [RETEMA](#).

In addition, all project partners worked with the press individually (at European and national level) to present their work to their respective target groups in order to enhance networking and communication with them. For details, please see the chapter 2.4. Other dissemination and communication activities.

1.8. Final Booklet

A final booklet was produced by EBA in November 2022 to provide a summary of REGATRACE main achievements and recommendations, and to increase the involvement of multipliers and businesses. This publication is available in English and in 9 languages (Czech, Dutch, Estonian, French, German, Italian, Lithuanian, Polish, Spanish). The Final Booklet is accessible for download on the project website in the Deliverable area under “WP8 – Dissemination, communication & exploitation”.

1.9. European transferability

Over the course of the project, REGATRACE partners have been encouraged to participate in events related to the biogas/biomethane sectors in order to give visibility to the project and reinforce the community around REGATRACE. The project partners identified the most suitable conferences dealing with the production and use of biomethane.

In addition to the networking and dissemination activities of the project partners in their home countries, REGATRACE also intended to address stakeholders in other countries having showed a strong interest in the project: Cyprus, Norway, Portugal, Hungary, and Serbia. The proper exploitation and transferability of REGATRACE results were ensured through the organisation of **5 dedicated workshops** in these countries. These events, through the involvement of the main local/national

stakeholders, intended to consolidate and exchange the concepts and outputs developed by the project (e.g., on registries, guarantees of origin, REGATRACE trading system, Power-to-Methane Sustainability), and to possibly trigger a replication effect.

On 28 June 2022, an online meeting was organized in Norway with the participation of EBA, ERGaR, AIB, Biogass Norge, and Biogass Oslofjord. The meeting focused on biomethane market in Norway, and the perspectives of guarantee of origins in the country.

No workshops were organized in Cyprus, Portugal, Hungary, and Serbia, due to the COVID-19 restrictions and the lack of maturity of these countries to host dedicated events focused on REGATRACE's priorities.

1.10. Final Conference

A full-day project conference was organised by EBA on 16 November 2022 to present the main results and impacts of REGATRACE on the biomethane industry. Over **100 participants and 20 speakers** gathered in Brussels to discuss the latest developments to boost biomethane trading across Europe. The project partners and external experts from the renewable gas sector highlighted that cross-border trading of biomethane will be essential to ensure the EU can deliver 35 bcm of biomethane by 2030.

2. Monitoring and reporting of dissemination/communication activities of the project partners

Since the beginning of the project, EBA has regularly evaluated impacts and results achieved through REGATRACE dissemination/communication activities. Each partner was in charge of monitoring its dissemination/communication activities and reporting the progress.

This section provides information on the dissemination/communication activities carried out by the project partners between 2019 and 2022.¹

2.1. All dissemination and communication activities between 2019 and 2022

Between 2019 and 2022, the REGATRACE partners presented the project's activities and outputs at 130 third-party **events** all around Europe, **reaching more than 8,500 people**. In addition, the project partners attended 29 third-party events where they informally promoted REGATRACE and informed the target groups about the project's results.

The outputs of the project were valorized in 21 press articles published in local and European media, and in 31 articles published on REGATRACE partners' websites. A total of 76 newsletters were disseminated to the local stakeholders. The REGATRACE partners also promoted the project on social media with 145 posts reaching more than 10,600 impressions.
